Citation and commencement(a)

1.—(1) This Order may be cited as the [*name of principal area*] (Reorganisation of Community Governance) Order [*year*].

(2) [It shall come into force on 1st April [*year*].]

(3) [It shall come into force on [*any date*] [the day after that on which it is made]].(b)

(4) [Subject to paragraphs (5) and (6) below, this Order comes into force on 1st April [*year*]].(c)

(5) Article [*number of article establishing parish electoral arrangement, i.e. numbers of parish councillors and names of parish wards*] shall come into force on the ordinary day of election of councillors in [*year*]].(d.)

(6) For the purposes of:

- (a) this article,
- (b) article [*Calculation of budget requirement*]; and
- (c) proceedings preliminary or relating to the election[s](e) of parish councillors for the parish of [*name*], to be held on the ordinary day of election of councillors in [*year*],

this Order shall come into force on [15th October [*year preceding parish election*]] [the day after that on which it is made]](f).

Interpretation

2. In this Order—

[“borough” means the borough(g) of [*name of principal area*];]

- (a) Delete from order - note for drafter only – the example commencement provisions set out in article 1 of this model order are illustrative only, not exhaustive. The drafter will need to give careful thought to the commencement provision required as what is required will depend on the types of changes that the order will bring about and, in some cases, on relevant local circumstances. In some cases different articles will need to be commenced at different times and for different purposes.
 - (b) Delete from order – note for drafter only - where the Order makes only minor boundary changes to existing parishes it can come into force on any date. However, where boundary changes are more than minor and will affect many electors, the provisions which make those changes must come into force on 1st April before the next scheduled elections for the parishes concerned. This is because precepting authorities can only issue precepts for entire financial years (see footnote (c) below), and so that local people can vote for their new parish councillors.
 - (c) Delete from order – note for drafter only – Orders that create, alter or abolish parishes and group or de-group parishes should do so with effect from 1st April because parish precepts can only be issued for whole financial years. However, an order establishing a new parish council or new electoral arrangements must be made in time for the principal council to reflect those changes in the electoral register, ideally by 15 October before the election. It should be made no later than 39 working days before the election. However, the administrative deadline is traditionally taken to be 15 February before the election.
 - (d) Delete from order – note for drafter only - parish electoral arrangements, i.e. numbers of parish councillors and names and areas of parish wards, come into force at parish elections. Principal councils should note that it may be more convenient for a parish election to coincide with the next election due to take place in an associated district or London borough ward or county division.
 - (e) Delete from order – note for drafter only - under section 16 of the LGA 1972, an unwarded parish has a single parish election and a warded parish has a separate election in each parish ward, so use ‘election’ for an unwarded parish and ‘elections’ for a warded parish.
 - (f) Delete from order – note for drafter only – although the Order comes into force for parish administrative boundaries on 1st April and for parish electoral arrangements on the ordinary day of election, it must come into force early for the purpose of preparing for those elections. Likewise, the article which specifies an amount in relation to the new parish [*Calculation of budget requirement*] must come into force early so as to enable the billing authority to anticipate a precept equivalent to that amount when making its calculations in accordance with section 32 of the Local Government Finance Act 1992 (see regulation 3 of the Local Government Finance (New Parishes) Regulations 2008 (SI 2008/626)).
 - (g) The [non-]metropolitan district of [*name*] has the status of a borough.

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.(d)

4.—(1) A new parish, comprising the area outlined with a blue line on the map, shall be constituted within the [borough][city][county][district][London borough].

(2) The name of the new parish shall be [name].

(3) [The new parish shall have the alternative style of [community][neighbourhood][village].]

(4) [In consequence of paragraph (1) of this article, the area of the new parish shall cease to be part of the existing parish of [name of parish]](f).

[Calculation of budget requirement](g)

5. For the purposes of regulation 3 of the Local Government Finance (New Parishes) (England) Regulations 2008(h) there is specified in relation to the parish of [name] the sum of £[sum].]

- 6.—(1) There shall be a parish council for the parish of *[name]*(a).
(2) The name of that council shall be “The *[Community]* *[Neighbourhood]* *[Parish]* *[Village]* Council of *[name of parish]*”.(b)

Grouping or de-grouping parishes(c)

(6) To preserve the separate rights of each parish the common parish council shall be deemed to be a separate parish council for each parish in the group for the purposes of section 79 of the Charities Act 1993(g) (parochial charities) and any provisions of the Local Government Act 1972 with respect to the custody of parish documents.
(7) *[Each parish in the group which has an alternative style shall cease to have that style.]]*
(8) *[Each parish in the group shall have the alternative style *[community]* *[neighbourhood]* *[village]*.]*

[Adding the parish of *[name]* to the *[name of group]* group of parishes under the *[name of common parish council]*(h)]

Therefore, a parish may have less than five parish councillors if the parish is grouped under a common parish council so that the total number of parish councillors on the parish council is at least five. An unwarded parish has a single number of parish councillors but a warded parish has separate numbers of parish councillors for each parish ward.
- (b) Section 16(1) of the Local Government Act 1972 (c.70), as amended by section 101 of, and paragraph 6(2) of Schedule 5 to, the Local Government and Public Involvement in Health Act 2007 (c.28), provides for the minimum number of parish councillors on a parish council to be five. There is no minimum number of parish councillors for a parish.

(3) Any functions which would have been exercisable in relation to the account of the charter trustees or as the case may be their responsible financial officer if the charter trustees had not been dissolved shall on and after the date of dissolution be exercisable by the parish council or as the case may be the parish council’s responsible financial officer.]

Transitional provision

30.
