

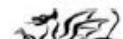

UK vessel application for access to European Union waters within 6-12 nautical miles

A Eligibility

*The UK retains rights of access in specific parts of European Union waters between 6 and 12 nautical miles from baselines in ICES divisions 4c and 7d-g for **qualifying vessels**. A qualifying vessel is one that can demonstrate that it has fished in any of the zone(s) below for the species specified in at least **4 of the 5 years between 2012 and 2016**.*

Only vessels that can provide evidence of eligibility at section D below will be considered as a qualifying vessel.

* "demersal fish" means all sea fish except salmon, migratory trout, mackerel, clupeoid fishes, sand eels, Norway pout, smelts, eels, great weevils, crustaceans and molluscs (other than squids).

The UK fisheries authorities and the European Commission will validate information provided in your application against official records. This may also include records of inspections and sightings data.
