

Permit application for the English Atlantic Bluefin Tuna Catch and Release Recreational Fishery 2025

Introduction

The Marine Management Organisation (MMO) and Defra are launching a bluefin tuna (BFT) catch and release recreational fishery (CRRF) for permitted vessels, which will take place in English waters. The fishery will be open between 18 July to 30 November 2025.

Detailed information can be accessed here.

To be eligible to apply you must:

- Be the owner of a vessel registered in the United Kingdom under the Merchant Shipping Act 1995.
- Have a vessel 5 metres or greater in overall length and powered by an engine/motor.
- Use rod and reel fishing gears only. No chumming will be permitted.
- Not have secured a permit for the UK commercial BFT fishery trial, or any other UK bluefin tuna catch and release recreational fishery.

How to complete and submit the application

You will need the following information before starting the application:

- Vessel details including: name, length, UKSR number, small commercial vessel certificate number (if applicable), external hull registration markings
- Vessel Owner details including: name, postal address, email address, phone number, names and contact details of any additional owners associated with the vessel
- The UK Ships Register (UKSR) certificate of the vessel.
- A photograph of the vessel displaying external registration marking on the hull to allow for identification.
- If your vessel is used for charter fishing trips, you will need to provide a copy of your Small Commercial Vessel Certificate (SCV2). The SCV2 must relate to the vessel within your application and must be valid to 30 November 2025.

Applications must be completed on an individual basis. Group applications will not be accepted. If an applicant owns more than one vessel, and wants to apply for more than one permit, a separate application will be required for each vessel.

When completing this form, you should:

- Answer all required questions. Incomplete applications forms will not be considered.
- Understand that it is your responsibility to check you have submitted all necessary evidence. In the event you fail to submit all evidence in your application, you must fully complete a new application before the deadline.

For your application to be considered, all evidence must be attached to the application form (up to 4 documents can be attached). If you fail to attach the necessary evidence your application will not be considered further.

MMO will not perform form completion checks until the application deadline has passed. If you identify that you have failed to submit all evidence in your application, you must fully complete a new application before the deadline.

Applications are open from 6 May and will close at midnight on Monday 2 June 2025. Applications received after this period will not be considered.

Evidenced by either:

- **A.** The applicant (owner of the vessel) having skippered, owned, or crewed on a vessel that participated in the CHART programme, and undertook recognised training in either Cefas UK CHART training and programme, or the FaSS funded 'Recreational Angling Training for Bluefin Tuna Permit Holders 2024' as crew, overseen by UKBFTA.
- **B.** Or the applicant (owner of the vessel) has an assigned master having skippered, owned, or crewed on a vessel that participated in the CHART programme, and undertook recognised training in either the Cefas UK CHART training and programme, or the FaSS funded 'Recreational Angling Training for Bluefin Tuna Permit Holders 2024' as crew, overseen by UKBFTA.
- 3. No verifiable UK training.

Remaining applications not in priority 1 or 2 will be allocated to priority 3. A minimum of ten permits will be allocated to this priority to ensure that some newer entrants can access the fishery. Newer entrants will be strongly encouraged to undertake training where possible. It is strongly recommended that successful applicants assigned master takes part in a recognised training programme before commencing their first BFT fishing trip.

Please note:

If you applied to attend training and the training was cancelled, please provide evidence (in the next section) of the date you were due to attend and a copy of the email confirming the session was cancelled. MMO may need to check with the training provider.

If you do not hold (either as the vessel owner or through your appointed master/skipper) the verifiable UK training of the Cefas UK CHART programme or the FaSS funded training detailed above, the applicant must select category/priority 3.

Section 4: Terms and conditions

By issuing this application process, UKSIA is not bound to accept any application, or grant a recreational bluefin tuna fishing permit to any applicant.

Applicants are responsible for ensuring that they understand the requirements for this application process. If any information is unclear, you can raise a query with the UKSIA at BFT.Recreational@marinemanagement.org.uk

The UKSIA will respond to all clarifications as quickly as possible but cannot guarantee a minimum response time. It is the responsibility of applicants to make sure that they raise any queries sufficiently early to allow them to submit their application by the deadline. If a query is relevant to other applicants, the UKSIA will share all clarifications with other applicants, as and when necessary.

Applicants are responsible for ensuring they submit a complete and accurate application and provide all the information requested. Only completed applications will be considered.

The MMO will not perform form completion checks until the application deadline has passed. If you identify that you have failed to submit all evidence in your application, or an applicant needs to make an amendment to an application submitted, the applicant must contact BFT.Recreational@marinemanagement.org.uk to withdraw their existing application and submit a new application that is fully completed with all evidence attached before the expiry of the application deadline.

Applicants can withdraw an application at any time by contacting the UKSIA at BFT.Recreational@marinemanagement.org.uk

Applications received after the deadline will not be considered. The UKSIA may also, at its own discretion, change the deadline and in such circumstances, the UKSIA will notify all applicants of any change via email.

MMO reserves the right to amend or withdraw this guidance and the application process at any time. This could include by way of example amending the process for submitting applications or extending the deadline.

Successful applicants are encouraged to attend a short online demonstration of the BFT reporting tool to understand how to deliver on their mandatory BFT reporting requirements run by the MMO prior to their permit being issued.

Attachments

The following attachments must be submitted with your application form in order for your submission to be valid:

- 1. The UK Ships Register (UKSR) certificate of the vessel.
- 2. A photograph of the vessel displaying external registration marking on the hull to allow for identification.
- 3. If your vessel is used for charter fishing trips, you will need to provide a copy of your Small Commercial Vessel Certificate (SCV2). The SCV2 must relate to the vessel within your application and must be valid to 30 November 2025.

Section 5: Declaration

By submitting this application, you are agreeing that the information you have provided is to the best of your knowledge, true and accurate.

Any personal information provided within your application will be handled only for the purpose of processing your application and in year monitoring.

The MMO reserves the right to use your details and statement within your application to validate/verify CHART participation with Cefas, BFT training undertaken by UKBFTA and/or other bodies overseeing other CHART Programmes (see section 3).

The UK is mandated to share information (shown below) with ICCAT when requested on fishing vessels used for the purposes of the commercial exploitation of bluefin tuna resources, which may be published by ICCAT. For more information read the ICCAT recommendation 22-08.
